# **Information Requested**

Information is requested on the item shown at the left. In 2008, Dummy Stamps Study Group member, Jim Noll found this image that appeared in the unknown test note section of Moneypedia, a German Paper Money Collectors web site. Jim's collecting specialty is currency test notes as well as ATM test notes & sheetlets.

None of Jim's Paper Money Test Note contacts in Europe have any information on it. It could be assumed that it was picked up at a ATM trade show where it was being used to demonstrate stamp issuing equipment.

The printing is red and black with a diagonal printing of "FAKE STAMPS" across each stamp. The ATM style sheetlet design closely resembles the issued Scott 2531A Liberty Torch ATM self-adhesive sheetlets issued in 1991. You will note that the "flames" of the torch are facing the opposite direction of those on the issued ATM sheetlets. A very curious item and any information is greatly appreciated.



Scott \$450+. Estimate \$200-300. Realized \$220.



Lot 993 U.S.; Test Stamp Issues, 1954, Nebraska Blue on White, Block of 4, #TD101. N.H., large margins all around, Very Fine. Scott \$800. Estimate \$150-200. Realized \$180.



Lot 994 U.S.; Test Stamp Issues, 1954, Nebraska Blue on Tan, #TD101a. N.H., margins all around, scarce, Very Fine. Scott \$800. Estimate \$150-200. Realized \$130.





Test stamps were created by BEP to test different tagging. One block glows yellow-green (zincorthosilicate); the other glows reddish-orange (calcium silicate). Scarce position pieces! Cat \$400. Estimate: \$ 250 Realized \$200



Lot 1913 \*\* (3019-23P) 1995 ANTIQUE AUTOMOBILES, TEST PANE PROOF, Vertical strip of 5 with 00 denomination, imperf on gummed stamp paper with simulated perforations. Realized \$350


